The first series, planned by Lord Acton and edited by him with Stanley Mordaunt Leathes, Sir Adolphus William Ward and G. W. Prothero, was launched in 1902 and totalled fourteen volumes, the last of them being an historical atlas which appeared in 1912. The period covered was from 1450 to 1910. Each volume includes an extensive bibliography. Cambridge Rules are believed to have had a significant influence on the modern football codes. The 1856 Cambridge Rules are claimed by some to have had an influence in the origins of Australian rules football. The 1863 Cambridge Rules is said to have had a significant influence on the creation of the original Laws of the Game of the Football Association.

Objectivity (science) It is thus related to the aim of testability and reproducibility. To be considered objective, the results of measurement must be communicated from person to person, and then demonstrated for third parties, as an advance in a collective understanding of the world. It is often linked to observation as part of the scientific method. Such demonstrable knowledge has ordinarily conferred demonstrable powers of prediction or technology. In science, objectivity refers to attempts to do higher quality research by eliminating personal biases (or prejudices), irrational emotions and false beliefs, while focusing mainly on proven facts and evidence

Something is subjective if it is dependent on minds (such as biases, perception, emotions, opinions, imaginary objects, or conscious experiences). If a claim is true exclusively when considering the claim from the viewpoint of a sentient being, it is subjectively true. For example, one person may consider the weather to be pleasantly warm, and another person may consider the same weather to be too hot; both views are subjective.
