CLASS CLAIMS Under the FAA, arbitration agreements are not invalid simply because they contain language disallowing class-wide arbitration, even in cases where claims by individual plaintiffs would be prohibitively expensive. LEGAL SYSTEM Contesting one's employer in the legal system is an expensive, protracted, uncertain, and emotionally draining process. EMPLOYEE RIGHTS Paradoxically, the starting point for understanding employee rights is a legal doctrine holding that employees do not have any right to be employed or to retain their employment.
