Communication privacy management theory privacy management theoretical frameworks, Petronio tested them using different methods including and not limited to qualitative and quantitative research Communication privacy management (CPM), originally known as communication boundary management, is a systematic research theory developed by Sandra Petronio in 1991. It suggests that individuals maintain and coordinate privacy boundaries (the limits of what they are willing to share) with various communication partners depending on the perceived benefits and costs of information disclosure. CPM theory aims to develop an evidence-based understanding of the way people make decisions about revealing and concealing private information. Petronio believes disclosing private information will strengthen one's connections with others, and that we can better understand the rules for disclosure in relationships through negotiating privacy boundaries 0529e0c31b

Cost accounting Cost accounting provides the detailed cost information that management needs to control current operations and plan for the future.
