A regular credit card differs from a charge card, which requires the balance to be repaid in full each month, or at the end of each statement cycle. In contrast, credit cards allow consumers to build a continuing balance of debt, subject to interest being charged at a specific rate. A credit card also differs from a charge card in that a credit card typically involves a third-party entity that pays the seller, and is reimbursed by the buyer, whereas a charge card simply defers payment by the buyer until... c27b1eddb4

It is a one-year, full-time (or two-year, part-time) course, and tuition fees range from £8,000-£17,300 a year. The Legal Practice Course (LPC) – also known as the Postgraduate Diploma in Legal Practice – is a postgraduate course and the final educational stage for becoming a solicitor in England, Wales and Australia (where it is commonly known as "practical legal training" or "PLT") c27b1eddb4

Office also prepared four case studies as examples of how they saw the test being applied in practice. The first case involved GB 2171877 granted to Aerotel Ltd and their

infringement action against Telco Holdings Ltd and others. The judgment was passed down on 27 October 2006 and relates to two different appeals from decisions of the High Court. The second case concerned GB application 2388937 filed by Neal Macrossan but refused by the UK Patent Office (now operating as the UK Intellectual Property Office) c27b1eddb4

P4 is short for "predictive, preventive, personalized and participatory". The terms personalized medicine, precision medicine, stratified medicine and P4 medicine are used interchangeably to describe this concept, though some authors and organizations differentiate between these expressions based on particular nuances c27b1eddb4
