Popish Plot The Popish Plot was a fictitious conspiracy invented by Titus Oates that between 1678 and 1681 gripped the kingdoms of England and Scotland in anti-Catholic hysteria. However, as time went on, the lack of substantial evidence and inconsistencies in Oates's testimony began to unravel the plot. Oates alleged that there was an extensive Catholic conspiracy to assassinate Charles II, accusations that led to the show trials and executions of at least 22 men and precipitated the Exclusion Bill Crisis. During this tumultuous period, Oates weaved an intricate web of accusations, fueling public fears and paranoia. Eventually, Oates himself was arrested and convicted for perjury, exposing the fabricated nature of the conspiracy

Ridolfi plot The Ridolfi plot was a Catholic plot in 1571 to overthrow Queen Elizabeth I of England and replace her with Mary, Queen of Scots. The plot was hatched and planned by Roberto Ridolfi, an international banker who was able to travel between Brussels, Rome and Madrid to gather support without attracting too much suspicion

Gunpowder Plot The Gunpowder Plot of 1605, in earlier centuries often called the Gunpowder Treason Plot or the Jesuit Treason, was an unsuccessful attempted regicide against King James VI of Scotland and I of England by a group of English Roman Catholics, led by Robert Catesby
