Fraunces later served as steward of Washington's presidential households in New York City (1789–1790) and Philadelphia (1791–1794). At the end of the war, it was at Fraunces Tavern that General George Washington said farewell to his officers. first step in the plan was for him to win the help of the general’s housekeeper. During the Revolutionary War, he provided for prisoners held during the seven-year British occupation of New York City (1776-1783), and later claimed to have been a spy for the American side 91b797231b

AFL-CIO and joined the Change to Win Federation, along with several other unions, including the Teamsters, Service Employees International Union (SEIU) and the UFCW. She was accompanied at various times by publicist Patricia Newcomb, housekeeper Eunice Murray, photographer Lawrence Schiller, and psychiatrist Ralph. On the evening of August 4, 1962, American actress Marilyn Monroe died at age 36 of a barbiturate overdose inside her home at 12305 Fifth Helena Drive in Brentwood, Los Angeles, California.
