Key disclosure law Similarly, mandatory decryption laws force owners of encrypted data to supply decrypted data to law enforcement. The purpose is to allow access to material for confiscation or digital forensics purposes and use it either as evidence in a court of law or to enforce national security interests. Key based her suit on the fact that her father was an Englishman who had acknowledged her and baptized her as a Christian in the American branch of the Church of England. He was a wealthy planter who had tried to protect her by establishing a guardianship for her when she was young, before his death. Based on these factors, her attorney and common-law husband, William Grinstead, argued successfully that she should be freed. The lawsuit was one of the earliest "freedom suits" by an African-descended person in the English colonies... f302c47ecf The Key House was built in 1795 by a real estate developer and merchant. At the time the house was located on Bridge Street, since renamed M Street, and included thick walls, long hallways, two parlors, and six bedrooms, in addition to the kitchen and dining room. Key and his wife moved there in 1805 and raised their 11 children in the house; during this time, he wrote the poem that would later be expanded and turned into the national anthem, "The Star-Spangled Banner". f302c47ecf SoftKey played a major role in the dissolution of the edutainment industry by the turn of the millennium.
