This unit is the same interval as the degree Celsius, used on the Celsius scale but the scales are offset so that 0 K on the Kelvin scale corresponds to absolute zero. For comparison, a temperature of 295 K corresponds to 21.85 °C and 71.33 °F. Another absolute scale of temperature is the Rankine scale, which is based on the Fahrenheit degree interval. 42dea9194e

Turbulence is caused by excessive kinetic energy in parts of a fluid flow, which overcomes the damping effect of the fluid's viscosity. For this reason, turbulence is commonly realized in low viscosity fluids. In general terms, in turbulent flow, unsteady vortices appear of many sizes which interact with each other... 42dea9194e

Mass Mass can be experimentally defined as a measure of the body's inertia, meaning the resistance to acceleration (change of velocity) when a net force is applied. Mass in modern physics has multiple definitions which are conceptually distinct, but physically equivalent. The object's mass also determines the strength of its gravitational attraction to other bodies. It was found that different atoms and different elementary particles, theoretically with the same amount of matter, have nonetheless different masses. It was traditionally believed to be related to the quantity of matter in a body, until the discovery of the atom and particle physics.
