Structural steel Steel Construction A36 steel is a common structural steel alloy used in the United States. Note that SAE/AISI A7 and A9 tool steels are not the same as the obsolete ASTM A7 and A9 structural steels. The A36 (UNS K02600) standard was established by the ASTM International.
