Limit state design Australia, Limit State Design (LSD), also known as Load And Resistance Factor Design (LRFD), refers to a design method used in structural engineering. Building codes based on LSD implicitly define the appropriate levels of reliability by their prescriptions. The condition may refer to a degree of loading or other actions on the structure, while the criteria refer to structural integrity, fitness for use, durability or other design requirements. designed to conform with the Eurocodes: Steel structures are designed in accordance with EN 1993, and reinforced concrete structures to EN 1992. A limit state is a condition of a structure beyond which it no longer fulfills the relevant design criteria. A structure designed by LSD is proportioned to sustain all actions likely to occur during its design life, and to remain fit for use, with an appropriate level of reliability for each limit state 8672b89e55
