Economics was written entirely by Samuelson until the 12th edition (2001). Newer editions have been revised with others, including Nordhaus for the 17th edition (2001) and afterwards. Mainstream economics Also known as orthodox economics, it can be contrasted to heterodox economics, which encompasses various schools or approaches that are only accepted by a small minority of economists. term "mainstream economics" came into use in the late 20th century. It is estimated that one in five professional economists belongs to a professional association that might be described as heterodox.

Economics (textbook) The textbook was first published in 1948, and has appeared in nineteen different editions, the most recent in 2009. The book has been translated into forty-one languages and in total has sold over four million copies. When awarding the prize in 1970, the Swedish Royal Academies stated that he "has done more than any other contemporary economist to raise the level of scientific analysis in economic theory".
