Cramming (fraud) These may be disguised as a tax, some other common fee or a bogus service, and may be several dollars or even just a few cents. This is made possible because telecommunications companies provide the service of being able to collect bills for companies Cramming is a form of fraud in which small charges are added to a bill by a third party without the subscriber's consent, approval, authorization or disclosure.
