"Microeconomics, Theory and Applications with In microeconomics, the contract curve or Pareto set is the set of points representing final allocations of two goods between two people that could occur as a result of mutually beneficial trading between those people given their initial allocations of the goods. Geoffrey L. The contract curve is the subset of the Pareto efficient points that could be reached by trading from the people's initial holdings of the two goods. All the points on this locus are Pareto efficient allocations, meaning that from any one of these points there is no reallocation that could make one of the people more satisfied with his or her allocation without making the other person less satisfied. It is drawn in the Edgeworth box diagram shown here, in which each person's allocation is measured vertically for one good and horizontally. The difference is not as clear as it used In economics, general equilibrium theory attempts to explain the behavior of supply, demand, and prices in a whole economy with several or many interacting markets, by seeking to prove that the interaction of demand and supply will result in an overall general equilibrium.
