Indiana's definition of "disorderly conduct" is modeled after the Model Penal Code's definition Disorderly conduct is a crime in most jurisdictions, such as the United States and China. Many types of unruly conduct may fit the definition of disorderly conduct, as such statutes are often used as "catch-all" crimes. lawful assembly of persons; commits disorderly conduct. Republican Party of Minnesota v. White S. Code of Judicial Conduct (2006). White, 536 U. 765 (2002), was a decision of the Supreme Court of the United States regarding the First Amendment rights of candidates for judicial office. In a 5–4 decision, the court ruled that Minnesota's announce clause, which forbade candidates for judicial office from announcing their views on disputed legal and political issues, was unconstitutional.
