Form I-130 It is one of numerous USCIS immigration forms. The USCIS officer who evaluates the petition is called the adjudicator. The remaining two steps are: The National Visa Center adds the beneficiary's name to a queue of people awaiting immigrant visas. After Form I-130, Petition for Alien Relative is a form submitted to the United States Citizenship and Immigration Services (or, in the rare case of Direct Consular Filing, to a US consulate or embassy abroad) by a United States citizen or Lawful Permanent Resident petitioning for an

immediate or close relative (who is not currently a United States citizen or lawful permanent resident) intending to immigrate to the United States. three-step process. As with all USCIS petitions, the person who submits the petition is called the petitioner and the relative on whose behalf the petition is made is called the beneficiary 9c640aa677

Form I-140 This is done in the case when the worker is deemed extraordinary in some sense or when qualified workers do not exist in the US. The form is 6 pages long with a separate 10-page instructions document as of 2016. When the National Visa Center (NVC) determines that an immigrant visa is available, the case can Form I-140, Immigrant Petition for Alien Worker is a form submitted to the United States Citizenship and Immigration Service (USCIS) by a prospective employer to petition an alien to work in the US on a permanent basis.
