chance of it remaining in state A. The sequence of states of the machine is a Markov chain. When it is in state E, there is a 70% chance of it moving to A and a 30% chance of it staying in E. In probability, a discrete-time Markov chain (DTMC) is a sequence of random variables, known as a stochastic process, in which the value of the next variable depends only on the value of the current variable, and not any variables in the past. For instance, a machine may have two states, A and E
