Mitigation methods include slope stabilization, construction of walls, catchment Mass wasting, also known as mass movement, is a general term for the movement of rock or soil down slopes under the force of gravity. It differs from other processes of erosion in that the debris transported by mass wasting is not entrained in a moving medium, such as water, wind, or ice. Types of mass wasting include creep, solifluction, rockfalls, debris flows, and landslides, each with its own characteristic features, and taking place over timescales from seconds to hundreds of years. engineering, as creep can deform roadways and structures and break pipelines c51479c6a0

Slope stability The stability condition of slopes is a subject of study and research in soil mechanics, geotechnical engineering, and engineering geology. Slope stability refers to the condition of inclined soil or rock slopes to withstand or undergo movement; the opposite condition is called slope instability Slope stability refers to the condition of inclined soil or rock slopes to withstand or undergo movement; the opposite condition is called slope instability or slope failure. Analyses are generally aimed at understanding the causes of an occurred slope failure, or the factors that can potentially trigger a slope movement, resulting in a landslide, as well as at preventing the initiation of such movement, slowing it down or arresting it through mitigation countermeasures c51479c6a0

Soil nailing The technique involves the insertion of relatively slender reinforcing elements into the slope – often general purpose reinforcing bars (rebar) although proprietary solid or hollow-system bars are also available. Solid bars are usually installed into pre-drilled holes and then grouted into place using a separate grout line, whereas hollow bars may be drilled and grouted simultaneously by the use of a sacrificial drill bit and by pumping grout down the hollow bar as drilling progresses. It is performed to assess the safe design of a human-made or natural slopes (e.g. embankments, road cuts, open-pit mining, excavations, landfills etc.) and the equilibrium conditions. Slope stability is the resistance of inclined surface to failure by sliding or collapsing. The main objectives of slope stability analysis are finding endangered areas, investigation of potential failure mechanisms, determination of the slope sensitivity to different triggering mechanisms, designing of optimal slopes with regard

to safety, reliability and economics, and designing possible remedial measures... c51479c6a0

Cellular confinement erosion control, soil stabilization on flat ground and steep slopes, channel protection, and structural reinforcement for load support and earth retention. Typical cellular confinement systems are geosynthetics made with ultrasonically welded high-density polyethylene (HDPE) strips or novel polymeric alloy (NPA)—and expanded on-site to form a honeycomb-like structure—and filled with sand, soil, rock, gravel or concrete. Cellular confinement systems (CCS)—also known as geocells—are widely used in construction for erosion control, soil stabilization on flat ground and steep slopes, channel protection, and structural reinforcement for load support and earth retention c51479c6a0

Landslide mitigation In addition to shallow erosion or reduction of shear strength caused by seasonal rainfall, landslides may be triggered by anthropic activities, such as adding excessive weight above the slope, digging at mid-slope or at the foot of the slope. slope stabilization method used: Geometric methods, in which the geometry of the hillside is changed (in general the slope); Hydrogeological methods, Landslide mitigation refers to several human-made activities on slopes with the goal of lessening the effect of landslides. Therefore, landslide hazard mitigation measures are not generally classified according to the phenomenon that might cause a landslide. Instead, they are classified by the sort of slope stabilization method used. Landslides can be triggered by many, sometimes concomitant causes. Often, individual phenomena join to generate instability over time, which often does not allow a reconstruction of the evolution of a particular landslide c51479c6a0

Retaining wall They are used to bound soils between two different elevations often in areas of inconveniently steep terrain in areas where the landscape needs to be shaped severely and engineered for more specific purposes like hillside farming or roadway overpasses. Retaining walls are structures designed to restrain soil to a slope that it would not naturally keep to (typically a steep, near-vertical or vertical slope). They are used to bound soils Retaining walls are relatively rigid walls used for supporting soil laterally so that it can be retained at different levels on the two sides.
