2022 Palestinian reconciliation agreement It was brokered in Algiers as part of the Fatah-Hamas reconciliation process, though it has not been successful in ending the Fatah-Hamas conflict, which began in the aftermath of the 2006 Palestinian legislative election and the subsequent 2007 Hamas takeover of the Gaza Strip. One-state solution The one-state solution is sometimes referred to as the bi-national state, owing to the hope that it would successfully deliver self-determination to Israelis and Palestinians in one country, thus granting both peoples independence as well as absolute access to all of the land. It stipulates the establishment of a single state within the boundaries of the former Mandatory Palestine, today consisting of the combined territory of modern-day Israel (excluding the annexed Golan Heights) and Palestine. The term one-state reality describes the belief that the current situation of the Israeli-Palestinian conflict on the ground is that of one de facto country.
