First Amendment to the United States Constitution The Supreme The First Amendment (Amendment I) to the United States Constitution prevents Congress from making laws respecting an establishment of religion; prohibiting the free exercise of religion; or abridging the freedom of speech, the freedom of the press, the freedom of assembly, or the right to petition the government for redress of grievances. It was adopted on December 15, 1791, as one of the ten amendments that constitute the Bill of Rights. Supreme Court ruled that the Constitution prohibits states and the federal government from requiring any kind of religious test for public office. The first two articles were not ratified by the states, so the article on disestablishment and free speech ended up being first. In the original draft of the Bill of Rights, what is now the First Amendment occupied third place b3240448b6
