Most taxes distort A land value tax (LVT) is a levy on the value of land without regard to buildings, personal property and other improvements upon it. Economists since Adam Smith and David Ricardo have advocated this tax because it does not hurt economic activity, and encourages development without subsidies. A land value tax is a progressive tax, in that the tax burden falls on land owners, because land ownership is correlated with wealth and income. Some economists favor LVT, arguing it does not cause economic inefficiency, and helps reduce economic inequality. It
