United Kingdom labour law The Pensions Act 2008 gives the right to be automatically enrolled in a basic occupational pension, whose funds must be protected according to the Pensions Act 1995. The Employment Rights Act 1996 gives the right to leave for child care, and the right to request flexible working patterns. This includes the right to a minimum wage of £11. The Working Time Regulations 1998 give the right to 28 days paid holidays, breaks from work, and attempt to limit long working hours. Contract cheating The term was coined in a 2006 study by Thomas Contract cheating is a form of academic dishonesty in which students pay others to complete their coursework. Hence, they coined the term "contract cheating" to include all outsourced academic work, regardless of whether it is from text-based or non-text-based disciplines. In contrast, Lancaster and Clarke are computer scientists who found evidence of students systematically outsourcing coding assignments. Contract cheating is a form of academic dishonesty in which students pay others to complete their coursework. The term was coined in a 2006 study by Thomas Lancaster and Robert Clarke as a more inclusive way to talk about all forms of academic work, as opposed to more outdated terms such as "term paper mill" or "essay mill", which refer to text-based academic outsourcing 844d8b6fb2
