Self-care is not only a solo activity, as the community—a group that supports the person performing self-care—overall plays a role in access to, implementation of, and success of self-care activities

The HCCA states that a person has the right to consent to or refuse treatment if they have mental capacity. In order to have capacity, a person must have the "ability" to understand and appreciate the consequences of the treatment decision. The law says that "a person is capable with respect to a treatment, admission to a care facility or a personal assistance service if the person is able to understand the information that is relevant to making a decision about the treatment, admission or... Nursing homes have traditionally been large institutions. Smaller community versions were developed around the 1970s. Some "community living" (CL) groups advocated for a different type of care and funding, which resulted in the creation of assisted living facilities.

Long COVID with autonomic dysfunction may benefit from increased intake of fluids, electrolytes and compression garments. The World Health Organization defines long COVID as starting three months after the initial COVID-19 infection, but other agencies define it as starting at four weeks after the initial infection.
