Specialized business valuation... Generally, there are three approaches taken, namely discounted cashflow valuation, relative valuation, and contingent claim valuation. Security analysis deals with finding the proper value of individual securities (i.e., stocks, bonds and derivatives). These are usually classified into debt securities, equities, or some hybrid of the two. They can also include derivatives such as tradeable credit derivatives, commodities, futures contracts and options even if some of these are not technically securities. IFRS have replaced many different national accounting standards around the world but have not replaced the separate accounting standards in the United States where US GAAP is applied. Valuations may be needed for various reasons such as investment analysis, capital budgeting, merger and acquisition transactions, financial reporting, taxable...

By comparing a company's financial statements in different time periods, the valuation expert can view growth or decline in revenues Business valuation is a process and a set of procedures used to estimate the economic value of an owner's interest in a business. In addition to estimating the selling price of a business, the same valuation tools are often used by business appraisers to resolve disputes related to estate and gift taxation, divorce litigation, allocate business purchase price among business assets, establish a formula for estimating the value of partners' ownership interest for buy-sell agreements, and many other business and legal purposes such as in shareholders deadlock, divorce litigation and estate contest. Here various valuation techniques are used by financial market participants to determine the price they are willing to pay or receive to effect a sale of the business

Typically, then, financial modeling is understood to mean an exercise in either asset pricing or corporate finance, of a quantitative nature. It is about translating a set of hypotheses about the behavior of markets or agents into numerical predictions. At the same time, "financial modeling" is a general term that means different things to different users; the reference usually relates either to accounting and corporate finance applications or to quantitative finance applications.
