In Colonial America, a few German Quakers issued the 1688 Germantown Quaker Petition Against Slavery, which marked the beginning of the American abolitionist movement. Before the Revolutionary War, evangelical colonists were the primary advocates for the opposition to slavery and the slave trade, doing so on the basis of humanitarian ethics... f7d22cf748

Herbert Storing The constitutional theorist and American politics scholar Walter Berns called him "the most profound man I have encountered in the field of American studies. Whiteness studies It is an interdisciplinary arena of inquiry that has developed beginning in the United States from white trash studies and critical race studies, particularly since the late 20th century. Nakayama Whiteness studies is the study of the structures that produce white privilege, the examination of what whiteness is when analyzed as a race, a culture, and a source of systemic racism, and the exploration of other social phenomena generated by the societal compositions, perceptions and group behaviors of white people. asserting, in the essay "Whiteness: A Strategic Rhetoric"; that whiteness is a product of "discursive formation"; and a "rhetorical construction".. It is focused on what proponents describe as the cultural, historical and sociological aspects of people identified as white, and the social construction of "whiteness" as an ideology tied to social status f7d22cf748

The first seventy-seven of these essays were published serially in the Independent Journal, the New York Packet, and The

Daily Advertiser between October 1787 and April 1788. A compilation of these 77 essays and eight others were published in two volumes as *The Federalist: A Collection of Essays, Written in Favour of the New Constitution, as Agreed upon by the Federal Convention, September 17, 1787*, by publishing firm J. & A. Angelou was the first poet Maya Angelou, an African-American writer who is best known for her seven autobiographies, was also a prolific and successful poet. return to the African-American oral tradition of speakers such as Frederick Douglass, Martin Luther King Jr. She has been called "the black woman's poet laureate", and her poems have been called the anthems of African Americans. She became a poet after a series of occupations as a young adult, including as a cast member of a European tour of *Porgy and Bess*, and a performer of calypso music in nightclubs in the 1950s. Angelou studied and began writing poetry at a young age, and used poetry and other great literature to cope with trauma, as she described in her first and most well-known autobiography, *I Know Why the Caged Bird Sings* f7d22cf748

Civil rights movement (1865–1896) Washington (1856–1915). party. Reconstruction lasted The civil rights movement (1865–1896) aimed to eliminate racial discrimination against African Americans, improve their educational and employment opportunities, and establish their electoral power, just after the abolition of slavery in the United States. The period from 1865 to 1895 saw a tremendous change in the fortunes of the Black community following the elimination of slavery in the South. The most important civil rights leaders of this period were Frederick Douglass (1818–1895) and Booker T f7d22cf748

African-American literature 1753–1784). Phillis Wheatley was an enslaved African woman who became the first African American to publish a book of poetry, which was published in 1773. Olaudah Equiano (c. 1745–1797) was an African man who wrote *The Interesting Narrative of the Life of Olaudah Equiano*, an autobiography published in 1789 that became one of the first influential works about the transatlantic slave trade and the experiences of enslaved Africans. known for his *Appeal to the Coloured Citizens of the World* (1829); Frederick Douglass, who was a former enslaved person who became a prominent abolitionist African American literature is the body of literature produced in the United States by writers of African descent. Her collection, was titled *Poems on Various Subjects, Religious and Moral*. His work was published sixteen years after Phillis Wheatley's work (c f7d22cf748

Throughout the 1890s, Wells documented lynching of African-Americans in the United States in articles and through pamphlets such as *Southern Horrors: Lynch Law in all its Phases* and *The Red Record*, which debunked the fallacy frequently voiced by whites at the time – that all Black lynching victims were guilty of crimes. Wells exposed the brutality of lynching, and analyzed its sociology, arguing... f7d22cf748 The Jeremiad has been documented since the time of the biblical prophet Jeremiah; its uses have been both religious and sociopolitical. Scholars first traced an American Jeremiad starting with the Puritans advocating for freedom from England's oppression. Later scholars identified a distinct African-American or Black Jeremiad that adapted the form to criticize slavery and discrimination and advocate for sociopolitical change. f7d22cf748
