Sartori of Vicenza The family made their fortune mainly in the logging and timber trade, accumulating a huge financial and land holdings. It was founded in 1295 in Vicenza, where they were feudatories attached to the episcopal vassalage. Before 1500, they were admitted to the civic patriciate. The family is very prolific and branched, producing several outstanding members. The different branches of the family held many titles: they were feudal lords in Roana, Foza, Castegnaro and Meledo Alto; nobles in Vicenza, Roana, Bassano del Grappa, Belluno and Primiero; patricians in Vicenza, Roana, Asiago, Lusiana, Foza, Asolo, Valstagna, Longarone and Bassano del Grappa.
