Inductive reasoning The types of inductive reasoning include generalization, prediction, statistical syllogism, argument from analogy, and causal inference Inductive reasoning refers to a variety of methods of reasoning in which the conclusion of an argument is supported not with deductive certainty, but at best with some degree of probability. the evidence provided. Unlike deductive reasoning (such as mathematical induction), where the conclusion is certain, given the premises are correct, inductive reasoning produces conclusions that are at best probable, given the evidence provided 13c1b98f60

The book presented a body of evidence that the diversity of life arose by common descent through a branching pattern of evolution. His On the Origin of Species (or, more completely, On the Origin of Species by Means of Natural Selection, or the Preservation of Favoured Races in the Struggle for Life) is a work of scientific literature by Charles Darwin that is considered to be the foundation of evolutionary biology. Darwin's book introduced the scientific theory that populations evolve over the course of generations through a process of natural selection, although Lamarckism was also included as a mechanism of lesser importance. The second law of thermodynamics establishes the concept of entropy as a physical property of a thermodynamic system. It predicts whether

Second law of thermodynamics A simple statement of the law is that heat always flows spontaneously from hotter to colder regions of matter (or 'downhill' in terms of the temperature gradient). that the second law must hold in a statistical sense. Another statement is: "Not all heat can be converted into work in a cyclic process. ". That is, the second law will hold on average, with a statistical variation on the order of $1/\sqrt{N}$ where N is the number of particles. G factor (psychometrics) The g factor typically accounts for 40 to 50 percent of the between-individual performance differences on a given cognitive test, and composite scores ("IQ scores") based on many tests are frequently regarded as estimates of individuals' standing on the g factor. It is a variable that summarizes positive correlations among different cognitive tasks, reflecting the assertion that an individual's performance on one type of cognitive task tends to be comparable to that person's performance on other kinds of cognitive tasks. considerably lower g loadings than many tests that involve reasoning. The terms IQ, general intelligence, general cognitive ability, general mental ability, and simply intelligence are often used interchangeably to refer to this. While the existence of g as a statistical regularity is well-established and uncontroversial The g factor is a construct developed in psychometric investigations of cognitive abilities and human intelligence 13c1b98f60
