Jamil el-Banna Spanish extradition warrant for allegedly having been connected to al-Qaeda in Madrid. On 20 December, he was released on bail of £50,000, part of which Jamil Abdul Latif el-Banna (Arabic: جميل عبد اللطيف البنا, Ġamīl ‘Abdu ‘l-Laṭīf al-Bannā’), born 28 May 1962, is a Jordanian of Palestinian origin, with refugee status in the United Kingdom, who had been living in north-west London. He was abducted in November 2002 by the CIA from the Gambia while on a business trip, and suffered extraordinary rendition to Bagram, Afghanistan, where he was held and interrogated by the CIA until March 2003. He was transferred to military custody at Guantanamo Bay detainment camp in March 2003, and held there until 19 December 2007 48eb2fb8cf

A vociferous critic of fraud in the European Institutions, he himself was convicted of benefit fraud in 2007 for which he served a nine-month prison sentence and was described by the trial judge as "a truly dishonest man". The scandal ignited a debate as to how an MEP could receive a prison sentence, yet keep his seat in the European Parliament. Ira Einhorn 1981, just days before his murder trial was to begin, Einhorn skipped bail and fled to Europe. His moniker, "the Unicorn", was derived from his surname; Einhorn means "unicorn" in German. As an environmental activist, Einhorn was a speaker at the first Earth Day event in Philadelphia in 1970. Eighteen months later, police found her partially decomposed body in a trunk in Einhorn's closet. On September 9, 1977, Einhorn's ex-girlfriend Holly Maddux disappeared following a trip to collect her belongings from the apartment she and Einhorn had shared in Philadelphia, Pennsylvania. He lived there for the next seventeen years and married a Swedish Ira Samuel Einhorn (May 15, 1940 – April 3, 2020), known as "The Unicorn Killer", was an American environmental activist and murderer 48eb2fb8cf

Sydney siege inquest not have granted bail for the murder charge because the DPP did not present evidence of a discredited alibi. Bram Fischer He was sentenced to life imprisonment and diagnosed with cancer while in prison. was released on bail to handle a patent case in London. In his appeal to Court in the bail application he stated: Abraham Louis Fischer (23 April 1908 – 8 May 1975) was a South African Communist lawyer of Afrikaner descent with partial Anglo-African ancestry from his paternal grandmother, notable for anti-apartheid activism and for the legal defence of anti-apartheid figures, including Nelson Mandela, at the Rivonia Trial. He applied for bail to attend to his case. Following the trial, he was himself put on trial accused of furthering communism. The South African Prisons Act was extended to include his brother's house in Bloemfontein where he died two months later 48eb2fb8cf

After his arrest, Einhorn fled the country and spent twenty-two years in Europe before being extradited to the United States. He took the stand in his own defense, claiming his ex... 48eb2fb8cf

Ashley Mote had applied to the European Court of Justice to have his immunity as an MEP upheld and that it was an abuse of process for the Crown Court not to have suspended Ashley Mote (25 January 1936 – 30 March 2020) was a British politician who was a member of the European Parliament (MEP) for South East England from 2004 to 2009. Elected representing the UK Independence Party, he became a non-inscrit one month into his term after UKIP withdrew the whip from him due to investigation into his expenses 48eb2fb8cf

2009–2011 detention of American hikers by Iran reportedly played a key role in negotiations with Iran and may have paid the almost \$1 million bail. The two men were released from prison and flown back to On July 31, 2009, three Americans, Joshua Fattal, Sarah Shourd and Shane Bauer were taken into custody by Iranian border guards for crossing into Iran while hiking near the Iranian border in Iraqi Kurdistan 48eb2fb8cf

In December 2022, he lost his final appeal against extradition request by Indian agencies. Since... 48eb2fb8cf Following his release, and subsequent return to the United Kingdom, Jamil el-Banna was arrested and questioned when arriving in London, on charges by a Spanish court. Kizza Besigye Kizza Besigye, is a Ugandan physician, politician, and former military officer. sent to prison. Besigye allowed an early internal FDC election for a successor president, which took place on 24 November 2012. He served as the president of the Forum for Democratic Change (FDC) political party and was an unsuccessful candidate in Uganda's 2001, 2006, 2011, and 2016 presidential elections, losing all of them to the incumbent, Yoweri Museveni, who has been president of Uganda since 1986. The nature of the Warren Kizza Besigye Kifefe (; born 22 April 1956), commonly known by his nickname Colonel Dr. Efforts to apply for bail were futile since it was past court hours and his lawyers had to apply for bail on another day. The results of the 2006 elections were contested in court, and the court found massive rigging and disenfranchisement 48eb2fb8cf

Tim Carmody magistrates from hearing contested bail applications. Nirav Modi Modi applied for bail in the UK High Court on 3 May, a day after his remand was extended. In March 2018, Modi applied for bankruptcy protection in Manhattan, New York. Modi is being investigated as a part of the \$2 billion fraud case of Punjab National Bank (PNB). All his requests for bail have been rejected as Nirav Deepak Modi (born 27 February 1971) is an Indian-born Belgian fugitive who was charged by Interpol and the Government of India for criminal conspiracy, criminal breach of trust, cheating and dishonesty including delivery of property, corruption, money laundering, fraud, embezzlement and breach of contract in August 2018. In June 2019, Swiss authorities froze a total of US\$6 million in Nirav Modi's Swiss bank accounts along with the assets. against him. In June 2018, Modi was reported to be in the UK applying for political asylum 48eb2fb8cf
