Will White He played all or parts of 10 seasons in Major League Baseball, primarily for the Cincinnati Reds in the National League (1878–1879) and the Cincinnati Red Stockings in the American Association (1882–1886). During the 1882 and 1883 seasons, he led the American Association in wins, compiling an 83–34 win–loss record and a 1.84 earned run average (ERA). He had three 40-win, and one 40-loss, seasons in Cincinnati. season, compiling a 44–27–1 managerial record. He is also remembered as the first, and for many years only, major league player to wear eyeglasses on the baseball field. The study of the history of marketing, as a discipline, is important because it helps to define the baselines upon which change can be recognised and understand how the discipline evolves in response to those changes.
