Givhan v. Western Line Consolidated School District protected speech under Garcetti, he filed an interlocutory appeal. While other circuits had ruled on the latter question, the Second never had. S. Justice William Rehnquist wrote the opinion, with a short concurrence by John Paul Stevens. The Court held unanimously in favor of a schoolteacher fired for her critical remarks in conversations with her principal. Freedom of speech in schools in the United States Supreme Court formally recognized that students do not "shed their constitutional rights to freedom of speech or expression at the schoolhouse gate". S. The Fourth Circuit held for a school district; The issue of school speech or curricular speech as it relates to the First Amendment to the United States Constitution has been the center of controversy and litigation since the mid-20th century. The First Amendment's guarantee of freedom of speech applies to students in public schools. Within a year two other circuits held in favor of schools

Smith Act trials of Communist Party leaders The trial was one of the country's most contentious legal proceedings The Smith Act trials of Communist Party leaders were a series of trials held from 1949 to 1958 in which leaders of the Communist Party of the United States (CPUSA) were accused of violating the Smith Act, a 1940 statute that set penalties for advocating the violent overthrow of the government. Appeals from these trials reached the US Supreme Court, which ruled on issues in *Dennis v. United States* (1951) and *Yates v. his role as attorney, directly address the jury and explain communist principles. United States* (1957). Education v. Doyle Healthy v. S. Justice William Rehnquist wrote the opinion. Doyle had begun teaching in Mt. Healthy. The test has also been expanded into mixed motive discrimination cases in employment law. The Court considered three issues: whether federal-question jurisdiction existed in the case, whether the Eleventh Amendment barred federal lawsuits against school districts, and whether the First and Fourteenth Amendments prevented the district, as a government agency, from firing or otherwise disciplining an employee for constitutionally protected speech on a matter of public concern where the same action might have taken place for other, unprotected activities.
