In a broader sense, the study of IR, in addition to multilateral relations, concerns all activities among states—such as war, diplomacy, trade, and foreign policy—as well as relations with and among other international actors, such as intergovernmental organizations (IGOs), international nongovernmental organizations (INGOs), international legal bodies, and multinational corporations (MNCs)

International relations is generally classified as a major multidiscipline of political science, along with comparative politics, political methodology, political theory, and public administration. It often draws heavily from other fields, including anthropology... Realism involves the strategic use of military force and alliances to boost global influence while maintaining a balance of power. War is seen as inevitably inherent in the anarchic conditions of world politics. Realism also emphasizes the complex dynamics of the security dilemma, where actions taken for security reasons can unintentionally lead to tensions between states.

Functionalism (international relations) Its roots can be traced back to the liberal and idealist traditions that started with Immanuel Kant and goes as far as Woodrow Wilson's "Fourteen Points" speech. Rather than the self-interest of nation states that realists see as a motivating factor, functionalists focus on common interests and needs shared by states (but also by non-state actors) in a process of global integration triggered by the erosion of state sovereignty and the increasing weight of knowledge and hence of scientists and experts in the process of policy-making.
