

# Denial Holocaust History On Trial

Holocaust denial has roots in postwar Europe, beginning with writers such as Maurice Bardèche and Paul Rassinier. In the United States, the Institute for Historical Review gave Holocaust denial a pseudo-scholarly platform and helped spread it globally.
