Primary care Primary care is the day-to-day healthcare given by a health care provider. In some localities, such a professional may be a registered nurse, a pharmacist, a clinical officer (as in parts of Africa), or an Ayurvedic or other traditional medicine professional (as in parts of Asia). Patients commonly receive primary care from professionals such as a primary care physician (general practitioner or family physician), a physician assistant, a physical therapist, or a nurse practitioner. Typically, this provider acts as the first contact and principal point of continuing Primary care is the day-to-day healthcare given by a health care provider. Depending on the nature of the health condition, patients may then be referred for secondary or tertiary care.
