Discovery (law) basis of its discovery rules. Conversely, a party or nonparty resisting discovery can seek the assistance of the court by filing a motion for a protective order. Discovery can be obtained from nonparties using subpoenas. This is by means of methods of discovery such as interrogatories, requests for production of documents, requests for admissions and depositions. When a discovery request is objected to, the requesting party may seek the assistance of the court by filing a motion to compel discovery. In 1938, the promulgation of the Federal Rules of Civil Procedure (FRCP) (pursuant to the Rules Enabling Act) created for Discovery, in the law of common law jurisdictions, is a phase of pretrial procedure in a lawsuit in which each party, through the law of civil
