The paper is also known for introducing new techniques that Gödel invented to prove the incompleteness theorems. Their name comes from the example sentence "Every farmer who owns a donkey beats it", in which "it" acts as a donkey pronoun because it is semantically but not syntactically bound by the indefinite noun phrase "a donkey".
