The Kepler problem is named after Johannes Kepler, who proposed Kepler's laws of planetary motion (which are part of classical mechanics and solved the problem for the orbits of the planets) and investigated the types of forces that would result in orbits obeying those laws (called Kepler's inverse problem).

A central force is a force (possibly negative) that points from the particle directly towards a fixed point in space, the center, and whose magnitude only depends on the distance of the object to the center. The solution of this problem is important to classical mechanics, since many naturally occurring forces are central. In classical mechanics, the central-force problem is to determine the motion of a particle in a single central potential field. In a few important cases, the problem can be solved analytically, i.e., in terms of well-studied functions such as trigonometric functions.

Quantum mechanics can describe many systems that classical physics cannot. Classical physics can describe many aspects of nature at an ordinary (macroscopic and (optical) microscopic) scale, but is not sufficient for describing them at very small submicroscopic (atomic and subatomic) scales. Classical mechanics can be derived from quantum mechanics as an approximation that is valid at ordinary scales.

Quantum mechanics It is the foundation of all quantum physics, which includes quantum chemistry, quantum field theory, quantum technology, and quantum information science. Quantum mechanics arose gradually from theories to explain observations that could not be reconciled with classical physics, such as Max Planck's solution in Quantum mechanics is the fundamental physical theory

that describes the behavior of matter and of light; its unusual characteristics typically occur at and below the scale of atoms
