The first Complete Idiot's Guides were published in 1993 on MS-DOS and IBM PC compatibles. The title track, noted for its politically conscious lyrics, was released as the album's second single and was the band's first music video. The album's cover art, featuring the band's mascot Vic Rattlehead in front of a desolated United Nations Headquarters, was created by Ed Repka.
