In the United States, works published before January 1, 1930, are in the public domain. These exclusive rights are subject to a time and generally expire 70 years after the author's death or 95 years after publication. With the stated purpose to promote art and culture, copyright law assigns a set of exclusive rights to authors: to make and sell copies of their works, to create derivative works, and to perform or display their works publicly e158b61dcc
