Quality can refer to how maintainable software is, to its stability, speed, usability, testability, readability, size, cost, security, and number of flaws or "bugs", as well as to less measurable qualities like elegance, conciseness, and customer satisfaction, among many other attributes. Typestates define valid sequences of operations that can be performed upon an instance of a given type. This state information is used to determine at compile-time which operations are valid to be invoked upon an instance of the type.
