Article 104, paragraph 1 of the Basic Law for the Federal Republic of Germany (ratified in 1949) provides that deprivations of liberty Habeas corpus () is a legal procedure invoking the jurisdiction of a court to review the unlawful detention or imprisonment of an individual, and request the individual's custodian (usually a prison official) to bring the prisoner to court, to determine whether their detention is lawful

He believed that to better connect with people in an increasingly secularized world, some of the Church's practices needed to be improved and presented in a more understandable and relevant way.
