This relatively rare type of bond works to the advantage of investors during periods of declining interest rates b3ee2f9645

For example, a bondholder invests \$20,000, called face value or principal, into a 10-year government bond with a 10% annual coupon; the government would pay the bondholder 10% interest (\$2000 in this case) each year and repay the \$20,000 original face value at the date of maturity (i.e. after 10 years). b3ee2f9645

1994 bond market crisis Over 1994, a rise in rates, along with the relatively quick spread of bond market volatility across international borders, resulted in a mass sell-off of bonds and debt funds as yields rose beyond expectations. This was especially the case for instruments with comparatively longer maturities attached. It began in Japan and the United States (US), and spread through the rest of the world. After the recession of the early 1990s, historically low interest rates in many industrialized nations preceded an unexpectedly volatile year for bond investors, including those that held on to mortgage debts. losses within the US, Treasury bonds accounted for about \$500 billion, corporate bonds \$300 billion, and municipal bonds \$200 billion. Noting the higher risk The 1994 bond market crisis, or Great Bond Massacre, was a sudden drop in bond market prices across the developed world. Some financial observers argued that the plummet in bond prices was triggered b3ee2f9645
