National Bureau of Economic The post-World War I recession was an economic recession that hit much of the world in the aftermath of World War I. In the United States, 1918-1919 saw a modest economic retreat, but the second part of 1919 saw a mild recovery. There are many definitions of a business cycle. The simplest defines recessions as two consecutive quarters of negative GDP growth. More satisfactory classifications are provided by, first including more economic indicators and second by looking for more data patterns than the two quarter definition. In debt financing, companies borrow capital from a bank, in the expectation that the borrowed capital may be used to generate a return on investment greater than the interest rates. Failure of a borrower to continue paying interest is an example of default, which may be followed by bankruptcy proceedings. Collateral is sometimes given in the event of default. ec89af0f91
