Comitology The official term for the process is committee procedure. Article 7 paragraph 5 of the Comitology Decision states that references of the Comitology in the European Union (EU) refers to a process by which EU law is implemented or adjusted by the European Commission working in conjunction with committees of national representatives (at civil service level) from the EU member states, colloquially called "comitology committees". Comitology committees are part of the EU's broader system of committees that assist in the making, adoption, and implementation of EU laws.
