The fragmentation of electronic trading platforms has allowed dark pools to be created, and they are normally accessed through crossing networks or directly among market participants via private contractual arrangements. Liquidity on these markets is called dark pool liquidity. Generally, dark pools are not available to the public, but in some cases, they may be accessed 1093f13e1d
