Big Four accounting firms None of the "firms" within the Big Four is actually a single firm; rather, they are professional services networks. The four are often grouped because they are comparable in size relative to the rest of the

market, both in terms of revenue and workforce; they are considered equal in their ability to provide a wide scope of professional services to their clients; and, among those looking to start a career in professional services, particularly accounting, they are considered equally attractive networks to work in, because of the frequency with which these firms engage with Fortune 500 companies.
