Slaves were widely in labour in irrigation, mining, and animal husbandry, but most commonly as soldiers, guards, domestic workers. The use of slaves for hard physical labor early on in Muslim history led to several destructive slave revolts, the most notable being the Zanj Rebellion of 869–883. Many rulers also used slaves in the military and administration to such an extent that slaves could seize power, as did the Mamluks 0f3697a925
