Under this new policy when the police encounter individuals using or in possession of drugs, the substance is confiscated and the individual is referred to a Dissuasion Commission. Addiction Repetitive drug use can alter brain function in synapses similar to natural rewards like food or falling in love in ways that perpetuate craving and weakens self-control for people with pre-existing vulnerabilities.
