German-Soviet economic relations (1934-1941) In August of that year, the countries expanded their economic relationship by entering into a Trade and Credit agreement whereby the Soviet Union sent critical raw materials to Germany in exchange for weapons, military technology and civilian machinery. Trade between the two sides decreased. Following several years of high tension and rivalry, the two governments began to improve relations in 1939. That deal accompanied the Molotov-Ribbentrop Pact, which contained secret protocols dividing central Europe between them, after which both Nazi forces and Soviet forces invaded territories listed within their "spheres of influence". imports from Imperial Russia and the Soviet Union from 1912 to 1933: While Soviet exports into Germany were a small percentage of Germany's imports due After the Nazis rose to power in Germany in 1933, relations between Nazi Germany and the Soviet Union began to deteriorate rapidly f0989e1cdf

Sperm donation The male is known as a sperm donor and the sperm they provide is known as "donor sperm" because the intention is that the male will give up all legal rights

to any child produced from the sperm, and will not be the legal father. Where pregnancies go to full term, the sperm donor will be the biological father of every baby born from their donations. Sperm donation may also be known as "semen donation". Despite the shortage, sperm exports from the UK are legal and donors may remain. Sperm donation is the provision by a male of their sperm with the intention that it be used in the artificial insemination or other "fertility treatment" of one or more females who are not their sexual partners in order that they may become pregnant. Protein adulteration in China These adulterants can be used to inflate the apparent protein content of products, so that inexpensive ingredients can pass for more expensive, concentrated proteins. protein export scandal inspired a significant amount of US media attention to Chinese food safety concerns, and increased unease about Chinese imports amongst In China the adulteration and contamination of food and feed ingredients with inexpensive melamine and other compounds, such as cyanuric acid, ammeline and ammelide, are common practice. Reports that cyanuric acid may be an independently and potentially widely used adulterant in China have heightened concerns for animal and human health. Melamine by itself has not been thought to be toxic to animals or humans except possibly in very high concentrations, but the combination of melamine and cyanuric acid has been implicated in kidney failure f0989e1cdf

Charcoal trafficking in Somalia resolution 2036 which imposed an embargo on the export of charcoal from Somalia. In the 1990s, the Somali Civil War, destructive El Niño floods, and reduced access to the European market caused the former prosperous banana industry to collapse, leading to an increase in reliance on the charcoal trade.
